PROPANE ASSISTANCE LOAN POLICY

OBJECTIVE:

The Propane Assistance Loan provides financial assistance to enrolled Tribal members who may not have the funds on hand due to the rise in heating cost this winter. In order for the loan to be repaid, the recipient must pledge their next Per Capita distribution as collateral.

LOAN TERMS: Amount, Term Fees:

- The maximum loan amount request is \$2000.
- The repayment of the Quick Loan will be automatically deducted from the Tribal member's next Per Capita or at most, for maximum of (18) months.
- Each application will be charged a \$50.00 processing Fee

ELGIBILITY REQUIREMENTS

- Applicant must be a Ho-Chunk Nation enrolled Tribal member.
- Applicant must be 18 years of age and a qualified recipient of the Per Capita distribution
- Applicant must sign a Ho-Chunk Nation Waiver & Assignment of Per Capita.
- Applicant must not have any pending or outstanding claims against their per capita distribution that exceed the amount of the loan or any applicable processing fees.

LOAN PROCESSING

- Applicant must complete and submit a loan application.
- Any application received before 3pm will be processed that same business day.
- First Nations Community Financial will verify that applications meet all of the requirements in the Propane Assistance Loan Policy and verify with the Ho-Chunk Nation Department of Treasury that the applicant's next per capita is available for repayment.

DENIED APPLICATION

If the eligibility requirements are not met, a letter will be mailed to the address on the application stating the reason for denial. Please provide a current phone number, if you want to be notified by phone.
