Small Business Grants for Wisconsin Native Business Owners

The Wisconsin Indigenous Economic Development Corporation (WIEDC) has received funding from the <u>Wisconsin Economic Development Corporation</u> (WEDC) to assist small businesses.

We are offering 32 grants to Wisconsin Native Business Owners, each in the amount of \$5,000.

To Qualify:

- You are 18 years or older
- Your business is Native owned
- Your business is located in Wisconsin
- Your business has been in operation for at least one year
- You reside in Wisconsin
- You answer the questions on the application
- You agree to attend one of WIEDC's awards ceremonies to receive your \$5,000 in person
- You email your Business Plan and business formation documents (proof of LLC, Schedule C of last year's tax return, etc.) to Ashley Rice at WIEDC by email to <u>ashleyr@wiedc.org</u>.

Your grant application will not be considered complete until all criteria listed above is met, including receipt of your business plan and business formation documents.

All awardees will receive notification of upcoming WIEDC awards ceremonies so that you may select an event to attend.

Please note that awards will be determined on a first-come, first-serve basis, and will be determined by receipt of eligible Native-owned business' complete application package.
